

## A NEW VIEW ON NEUTROSOPHIC MATRIX

**ABSTRACT.** In the present paper, we define a new kind of matrix called by a neutrosophic matrix, whose entries are all single-valued neutrosophic sets. So, we aim to be introduce a convenient tool for the problems, have uncertain inputs. We first give the definition of a neutrosophic matrix with its basic operations. Then we investigate the properties of the given operations and also prove that the family of all neutrosophic matrices is a vector space over a classical field.

**Key Words:** Neutrosophic set, single valued neutrosophic set, neutrosophic matrix.

### 1. INTRODUCTION

Neutrosopy was introduced by Smarandache to handle the indeterminate information. In the neutrosophic set, a truth-membership, an indeterminacy- membership and a falsity-membership are represented independently. Then Wang et al. [19] specified the definition of neutrosophic set which is called single valued neutrosophic set. The single valued neutrosophic set is a generalization of classical set, fuzzy set, intuitionistic fuzzy set etc. Single valued neutrosophic set is applied to algebraic and topological structures (see [3, 4, 5, 12, 14, 15]). Çetkin and AYGÜN [7] proposed the definitions of neutrosophic subgroups [5] and neutrosophic subrings [7] of a given classical group and classical ring, respectively. Also, Çetkin et al. [6] defined the neutrosophic submodules based on single valued neutrosophic sets and discussed their elementary properties.

In this paper, we introduce neutrosophic matrix in a completely different direction from Dhar et al. [8] and give some algebraic operations of it. Then, we prove that the neutrosophic matrix forms a vector space under component wise addition, multiplication and scalar multiplication.

This paper is organized as follows: Section 2 gives a brief summary of neutrosophic sets and operations on these sets. In section 3, we give the definition of neutrosophic matrix and investigate some of its algebraic operations. In section 4, we showed that neutrosophic matrix multiplication is associative and distributive. In addition, we proved that the set of all neutrosophic matrixes of order  $n \times n$  is an algebra and form a vector space under complement wise addition, complement wise multiplication and scalar multiplication.

## 2. PRELIMINARIES

In this chapter, we give some preliminaries about single valued neutrosophic sets and set operations, which will be called neutrosophic sets, for simplicity.

**Definition 2.1** [16] A neutrosophic set  $A$  on the universe of  $X$  is defined as  $A = \{ \langle x, t_A(x), i_A(x), f_A(x) \rangle, x \in X \}$  where  $t_A, i_A, f_A : X \rightarrow ]-0, 1^+[$  and  $-0 \leq t_A(x) + i_A(x) + f_A(x) \leq 3^+$ .

From philosophical point of view, the neutrosophic set takes the value from real standard or non standard subsets of  $]-0, 1^+[$ . But in real life applications in scientific and engineering problems it is difficult to use neutrosophic set with value from real standard or non-standard subset of  $]-0, 1^+[$ . Hence throughout this work, the following specified definition of a neutrosophic set known as single valued neutrosophic set is considered.

**Definition 2.2**[19] Let  $X$  be a space of points (objects), with a generic element in  $X$  denoted by  $x$ . A single valued neutrosophic set (SVNS)  $A$  on  $X$  is characterized by truth-membership function  $t_A$ , indeterminacy-membership function  $i_A$  and falsity-membership function  $f_A$ . For each point  $x$  in  $X$ ,  $t_A(x), i_A(x), f_A(x) \in [0, 1]$ .

A neutrosophic set  $A$  can be written as

$$A = \sum_{i=1}^n \langle t(x_i), i(x_i), f(x_i) \rangle / x_i, x_i \in X.$$

**Example 2.3**[19] Assume that  $X = \{x_1, x_2, x_3\}$ ,  $x_1$  is capability,  $x_2$  is trustworthiness and  $x_3$  is price. The values of  $x_1, x_2$  and  $x_3$  are in  $[0, 1]$ . They are obtained from the questionnaire of some domain experts, their

option could be a degree of "good service", a degree of indeterminacy and a degree of "poor service".  $A$  is a single valued neutrosophic set of  $X$  defined by

$$A = \langle 0.3, 0.4, 0.5 \rangle / x_1 + \langle 0.5, 0.2, 0.3 \rangle / x_2 + \langle 0.7, 0.2, 0.2 \rangle / x_3.$$

Since the membership functions  $t_A, i_A, f_A$  are defined from  $X$  into the unit interval  $[0, 1]$  as  $t_A, i_A, f_A : X \rightarrow [0, 1]$ , a (single valued) neutrosophic set  $A$  will be denoted by a mapping defined as  $A : X \rightarrow [0, 1] \times [0, 1] \times [0, 1]$  and  $A(x) = (t_A(x), i_A(x), f_A(x))$ , for simplicity.

**Definition 2.4** [14, 19] Let  $A$  and  $B$  be two neutrosophic sets on  $X$ . Then

(1)  $A$  is contained in  $B$ , denoted as  $A \subseteq B$ , if and only if  $A(x) \leq B(x)$ . This means that  $t_A(x) \leq t_B(x)$ ,  $i_A(x) \leq i_B(x)$  and  $f_A(x) \geq f_B(x)$ . Two sets  $A$  and  $B$  is called equal, i.e.,  $A = B$  iff  $A \subseteq B$  and  $B \subseteq A$ .

(2) the union of  $A$  and  $B$  is denoted by  $C = A \cup B$  and defined as  $C(x) = A(x) \vee B(x)$  where  $A(x) \vee B(x) = (t_A(x) \vee t_B(x), i_A(x) \vee i_B(x), f_A(x) \wedge f_B(x))$ , for each  $x \in X$ . This means that  $t_C(x) = \max\{t_A(x), t_B(x)\}$ ,  $i_C(x) = \max\{i_A(x), i_B(x)\}$  and  $f_C(x) = \min\{f_A(x), f_B(x)\}$ .

(3) the intersection of  $A$  and  $B$  is denoted by  $C = A \cap B$  and defined as  $C(x) = A(x) \wedge B(x)$  where  $A(x) \wedge B(x) = (t_A(x) \wedge t_B(x), i_A(x) \wedge i_B(x), f_A(x) \vee f_B(x))$ , for each  $x \in X$ . This means that  $t_C(x) = \min\{t_A(x), t_B(x)\}$ ,  $i_C(x) = \min\{i_A(x), i_B(x)\}$  and  $f_C(x) = \max\{f_A(x), f_B(x)\}$ .

(4) the complement of  $A$  is denoted by  $A^c$  and defined as  $A^c(x) = (f_A(x), 1 - i_A(x), t_A(x))$ , for each  $x \in X$ . Here  $(A^c)^c = A$ .

**Proposition 2.5** [19] Let  $A, B$  and  $C$  be the neutrosophic sets on the common universe  $X$ . Then the following properties are valid.

- (1)  $A \cup B = B \cup A, A \cap B = B \cap A$ .
- (2)  $A \cup (B \cup C) = (A \cup B) \cup C, A \cap (B \cap C) = (A \cap B) \cap C$ .
- (3)  $A \cup (B \cap C) = (A \cup B) \cap (A \cup C), A \cap (B \cup C) = (A \cap B) \cup (A \cap C)$ .
- (4)  $A \cap \tilde{\emptyset} = \tilde{\emptyset}, A \cup \tilde{\emptyset} = A, A \cup \tilde{X} = \tilde{X}, A \cap \tilde{X} = A$ , where  $t_{\tilde{\emptyset}} = i_{\tilde{\emptyset}} = 0, f_{\tilde{\emptyset}} = 1$  and  $t_{\tilde{X}} = i_{\tilde{X}} = 1, f_{\tilde{X}} = 0$ .
- (5)  $(A \cup B)^c = A^c \cap B^c, (A \cap B)^c = A^c \cup B^c$ .

**Definition 2.6** [6] Let  $A$  and  $B$  be two neutrosophic sets on  $X$  and  $Y$ , respectively. Then the cartesian product of  $A$  and  $B$  which is denoted by  $A \times B$  is a neutrosophic set on  $X \times Y$  and it is defined as  $(A \times B)(x, y) = A(x) \times B(y)$  where  $A(x) \times B(y) = (t_{A \times B}(x, y), i_{A \times B}(x, y), f_{A \times B}(x, y))$ , i.e.,

$$t_{A \times B}(x, y) = t_A(x) \wedge t_B(y), i_{A \times B}(x, y) = i_A(x) \wedge i_B(y) \text{ and } f_{A \times B}(x, y) = f_A(x) \vee f_B(y).$$

### 3. NEUTROSOPHIC MATRIX

In this section, we introduce neutrosophic matrix and give some algebraic operations of it.

**Definition 3.1** A neutrosophic matrix (NSM) of order  $m \times n$  is defined as  $A = [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle]$  where  $a_{ij}^T, a_{ij}^I, a_{ij}^F$  are called truth- membership, indeterminacy-membership, falsity-membership values of the  $ij$ -th element in  $A$  satisfying the condition  $0 \leq a_{ij}^T + a_{ij}^I + a_{ij}^F \leq 3$  for all  $i, j$ .

For simplicity, we write  $A = [a_{ij}]_{m \times n}$  where  $a_{ij} = \langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle$ .

Let  $\mathbf{F}_{m \times n}$  denotes the set of all NSMs of order  $m \times n$ . In particular  $\mathbf{F}_n$  denotes the set of all NSMs of order  $n$ .

**Example 3.2** We would represent the Example 2.3 in matrix form of order  $3 \times 1$  as

$$\begin{bmatrix} (0.3, 0.4, 0.5) \\ (0.5, 0.2, 0.3) \\ (0.7, 0.2, 0.2) \end{bmatrix}$$

**Definition 3.3** Let  $a$  and  $b$  be two elements of a NSM such that  $a = \langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle$ ,  $b = \langle b_{ij}^T, b_{ij}^I, b_{ij}^F \rangle$ , then complement wise addition and multiplication is defined as

$$a + b = \langle \max\{a_{ij}^T, b_{ij}^T\}, \max\{a_{ij}^I, b_{ij}^I\}, \min\{a_{ij}^F, b_{ij}^F\} \rangle$$

$$a \bullet b = \langle \min\{a_{ij}^T, b_{ij}^T\}, \min\{a_{ij}^I, b_{ij}^I\}, \max\{a_{ij}^F, b_{ij}^F\} \rangle$$

$$\text{We say } \max\{a_{ij}^T, b_{ij}^T\} = a_{ij}^T + b_{ij}^T \text{ and } \min\{a_{ij}^T, b_{ij}^T\} = a_{ij}^T \cdot b_{ij}^T$$

**Definition 3.4 Some algebraic operations of NSMs**

Let  $A$  and  $B$  be two NSMs such that  $A = [a_{ij}]_{m \times n}$ ,  $B = [b_{ij}]_{m \times n}$ .

1) Matrix addition and subtraction are given by

$$A + B = \langle \max\{a_{ij}^T, b_{ij}^T\}, \max\{a_{ij}^I, b_{ij}^I\}, \min\{a_{ij}^F, b_{ij}^F\} \rangle \text{ and}$$

$$A - B = \langle a_{ij}^T - b_{ij}^T, a_{ij}^I - b_{ij}^I, a_{ij}^F - b_{ij}^F \rangle \text{ where}$$

$$a_{ij}^T - b_{ij}^T = \begin{cases} a_{ij}^T, & \text{if } a_{ij}^T \geq b_{ij}^T; \\ 0, & \text{otherwise} \end{cases}$$

$$a_{ij}^I - b_{ij}^I = \begin{cases} a_{ij}^I, & \text{if } a_{ij}^I \geq b_{ij}^I; \\ 0, & \text{otherwise} \end{cases}$$

$$a_{ij}^F - b_{ij}^F = \begin{cases} a_{ij}^F, & \text{if } a_{ij}^F < b_{ij}^F; \\ 0, & \text{otherwise} \end{cases}$$

2) Component wise matrix multiplication is given by

$$A \circ B = \langle \min\{a_{ij}^T, b_{ij}^T\}, \min\{a_{ij}^I, b_{ij}^I\}, \max\{a_{ij}^F, b_{ij}^F\} \rangle$$

3) Let  $A$  and  $B$  be two NSMs of order  $m \times n$  and  $n \times p$ , respectively.

Then the matrix product  $AB$  is defined by

$$AB = \left\langle \sum_{k=1}^p a_{ik}^T \cdot b_{kj}^T, \sum_{k=1}^p a_{ik}^I \cdot b_{kj}^I, \prod_{k=1}^p a_{ik}^F \cdot b_{kj}^F \right\rangle \in \mathbf{F}_{m \times n}.$$

We can also write

$$AB = \left[ \max_k \{ \min \{ a_{ik}^T, b_{kj}^T \} \}, \max_k \{ \min \{ a_{ik}^I, b_{kj}^I \} \}, \min_k \{ \max \{ a_{ik}^F, b_{kj}^F \} \} \right],$$

where  $k = \overline{1, n}$ ,  $i = \overline{1, m}$ ,  $j = \overline{1, p}$ .

The product  $AB$  is defined if and only the number of columns of  $A$  is the same as the number of rows of  $B$ . We say that  $A$  and  $B$  are comfortable for multiplication.

4) Transpose of  $A$  is given by

$$A^T = \langle a_{ji}^T, a_{ji}^I, a_{ji}^F \rangle.$$

5) complement of  $A$

$$\overline{A} = \langle a_{ij}^F, 1 - a_{ij}^I, a_{ij}^T \rangle.$$

**Definition 3.5** Let  $A$  be a  $m \times n$  neutrosophic matrix. If all of its entries are  $\langle 0, 0, 1 \rangle$ , then  $A$  is called zero neutrosophic matrix and denoted by  $\mathbf{0}$ .

If all of its entries are  $\langle 1, 1, 0 \rangle$ , then  $A$  is called universal neutrosophic matrix and denoted by  $\mathbf{J}$ .

The  $n \times n$  identity matrix  $I_n$  is defined by  $\langle \lambda_{ij}^T, \lambda_{ij}^I, \lambda_{ij}^F \rangle$  such that  $\lambda_{ij}^T = \lambda_{ij}^I = 1$ ,  $\lambda_{ij}^F = 0$ , if  $i = j$  and

$$\lambda_{ij}^T = \lambda_{ij}^I = 0, \lambda_{ij}^F = 1, \text{ if } i \neq j.$$

**Definition 3.6** Let  $A = \langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle \in F_{m \times n}$  and  $k \in F$ . Then the neutrosophic scalar multiplication is defined as

$$kA = \langle \min \{ k, a_{ij}^T \}, \min \{ k, a_{ij}^I \}, \max \{ 1 - k, a_{ij}^F \} \rangle.$$

For the universal matrix  $\mathbf{J}$ ,

$$k\mathbf{J} = \langle \min \{ k, 1 \}, \min \{ k, 1 \}, \max \{ 1 - k, 0 \} \rangle = \langle k, k, 1 - k \rangle.$$

Under component wise multiplication ,

$$k\mathbf{J} \bullet A = \langle \min \{ k, a_{ij}^T \}, \min \{ k, a_{ij}^I \}, \max \{ 1 - k, a_{ij}^F \} \rangle = kA.$$

**Definition 3.7** Let  $A = \langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle$ ,  $B = \langle b_{ij}^T, b_{ij}^I, b_{ij}^F \rangle \in F_{m \times n}$ , then we write  $A \leq B$  if,  $a_{ij}^T \leq b_{ij}^T$ ,  $a_{ij}^I \leq b_{ij}^I$ ,  $a_{ij}^F \geq b_{ij}^F$  for all  $i, j$ .

**Example 3.8**  $\mathbf{0} \leq A \leq \mathbf{J}$ .

#### 4. MAIN RESULTS

In this section, we see that matrix multiplication is associative and distributive. We prove that the neutrosophic matrix forms a vector space under component wise addition, multiplication and scalar multiplication

**Theorem 4.1** For any NSMs  $A \in F_{m \times n}$ ,  $B \in F_{n \times p}$ ,  $C \in F_{p \times q}$ ,  $(AB)C = A(BC)$ .

**Proof**  $(AB)C$  and  $A(BC)$  are defined and are type of  $m \times q$ .

Let  $A = [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle]$ ,  $B = [\langle b_{jk}^T, b_{jk}^I, b_{jk}^F \rangle]$  and  $C = [\langle c_{kl}^T, c_{kl}^I, c_{kl}^F \rangle]$  such that the ranges of the suffixes  $i = \overline{1, m}$ ,  $j = \overline{1, n}$ ,  $k = \overline{1, p}$ ,  $l = \overline{1, q}$ .

(i,k)-th element of the product

$$AB = [\langle \sum_{j=1}^n a_{ij}^T \cdot b_{jk}^T, \sum_{j=1}^n a_{ij}^I \cdot b_{jk}^I, \prod_{j=1}^n a_{ij}^F \cdot b_{jk}^F \rangle].$$

The (i,1)-th element in the product  $(AB)C$  is the sum of products of the corresponding elements in the i-th row of  $AB$ , first column of  $C$  with k common. Hence, (i,1)-th element of

$$\begin{aligned} (AB)C &= [\langle \sum_{k=1}^p \left( \sum_{j=1}^n a_{ij}^T \cdot b_{jk}^T \right) c_{kl}^T, \sum_{k=1}^p \left( \sum_{j=1}^n a_{ij}^I \cdot b_{jk}^I \right) c_{kl}^I, \prod_{k=1}^p \left( \prod_{j=1}^n a_{ij}^F + b_{jk}^F \right) + c_{kl}^F \rangle] \\ &= [\langle \sum_{k=1}^p \sum_{j=1}^n a_{ij}^T \cdot b_{jk}^T \cdot c_{kl}^T, \sum_{k=1}^p \sum_{j=1}^n a_{ij}^I \cdot b_{jk}^I \cdot c_{kl}^I, \prod_{k=1}^p \prod_{j=1}^n (a_{ij}^F + b_{jk}^F + c_{kl}^F) \rangle]. \end{aligned}$$

(j,1)-th element of the product

$$BC = [\langle \sum_{k=1}^p b_{jk}^T \cdot c_{kl}^T, \sum_{k=1}^p b_{jk}^I \cdot c_{kl}^I, \prod_{k=1}^p (b_{jk}^F + c_{kl}^F) \rangle].$$

Now, the (i,1)-th element of the product  $A(BC)$  is the sum of products of the corresponding elements in the i-th row of  $A$  and first column of  $BC$ .

(i,1)-th element of

$$\begin{aligned} A(BC) &= [\langle \sum_{j=1}^n a_{ij}^T \left( \sum_{k=1}^p b_{jk}^T \cdot c_{kl}^T \right), \sum_{j=1}^n a_{ij}^I \left( \sum_{k=1}^p b_{jk}^I \cdot c_{kl}^I \right), \prod_{j=1}^n a_{ij}^F + \left( \prod_{k=1}^p (b_{jk}^F + c_{kl}^F) \right) \rangle] \\ &= [\langle \sum_{k=1}^p \sum_{j=1}^n a_{ij}^T \cdot b_{jk}^T \cdot c_{kl}^T, \sum_{k=1}^p \sum_{j=1}^n a_{ij}^I \cdot b_{jk}^I \cdot c_{kl}^I, \prod_{k=1}^p \prod_{j=1}^n (a_{ij}^F + b_{jk}^F + c_{kl}^F) \rangle]. \end{aligned}$$

Thus,  $(AB)C = A(BC)$ .

**Theorem 4.2** Let  $A \in F_{m \times n}$ ,  $B \in F_{n \times p}$  and  $C \in F_{n \times p}$ . Then  $A(B + C) = AB + AC$ .

**Proof** Let  $A = [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle]$ ,  $B = [\langle b_{jk}^T, b_{jk}^I, b_{jk}^F \rangle]$  and  $C = [\langle c_{jk}^T, c_{jk}^I, c_{jk}^F \rangle]$  such that the ranges of the suffixes  $i = \overline{1, m}$ ,  $j = \overline{1, n}$ ,  $k = \overline{1, p}$ .

(j,k)-th element of

$$\begin{aligned} B + C &= [\langle \max\{b_{jk}^T, c_{jk}^T\}, \max\{b_{jk}^I, c_{jk}^I\}, \min\{b_{jk}^F, c_{jk}^F\} \rangle] \\ &= [\langle b_{jk}^T + c_{jk}^T, b_{jk}^I + c_{jk}^I, b_{jk}^F \cdot c_{jk}^F \rangle]. \end{aligned}$$

(i,k)-th element in the product of  $A$  and  $B + C$ , that is of  $A(B + C)$  is the sum of the products of the corresponding elements in the  $i$ -th row  $A$  and  $k$ -th column of  $B + C$

$$A(B+C) = [\langle \sum_{j=1}^n a_{ij}^T (b_{jk}^T + c_{jk}^T), \sum_{j=1}^n a_{ij}^I (b_{jk}^I + c_{jk}^I), \prod_{j=1}^n (a_{ij}^F + b_{jk}^T \cdot c_{jk}^T) \rangle].$$

(i,k)-th element of  $(AB + AC)$

$$\begin{aligned} AB + AC &= [\langle \sum_{j=1}^n a_{ij}^T \cdot b_{jk}^T, \sum_{j=1}^n a_{ij}^I \cdot b_{jk}^I, \prod_{j=1}^n (a_{ij}^F + b_{jk}^F) \rangle + \sum_{j=1}^n a_{ij}^T \cdot c_{jk}^T, \sum_{j=1}^n a_{ij}^I \cdot c_{jk}^I, \prod_{j=1}^n (a_{ij}^F + c_{jk}^F) \rangle] \\ &= [\langle \sum_{j=1}^n (a_{ij}^T \cdot b_{jk}^T + a_{ij}^T \cdot c_{jk}^T), \sum_{j=1}^n (a_{ij}^I \cdot b_{jk}^I + a_{ij}^I \cdot c_{jk}^I), \prod_{j=1}^n (a_{ij}^F + b_{jk}^F) \prod_{j=1}^n (a_{ij}^F + c_{jk}^F) \rangle] \\ &= [\langle \sum_{j=1}^n a_{ij}^T (b_{jk}^T + c_{jk}^T), \sum_{j=1}^n a_{ij}^I (b_{jk}^I + c_{jk}^I), \prod_{j=1}^n (a_{ij}^F + b_{jk}^F \cdot c_{jk}^F) \rangle]. \end{aligned}$$

This completes the proof.

**Theorem 4.3** Let  $A, B \in \mathbf{F}_{m \times n}$ . If  $A \leq B$ , then for any  $C \in \mathbf{F}_{n \times p}$ ,  $AC \leq BC$  and for any  $D \in \mathbf{F}_{p \times m}$ ,  $DA \leq DB$ .

**Proof** Let  $A \leq B$ . Then  $a_{ik}^T \leq b_{ik}^T$ ,  $a_{ik}^I \leq b_{ik}^I$ ,  $a_{ik}^F \geq b_{ik}^F$  for  $i = \overline{1, m}$ ,  $k = \overline{1, n}$ .

By fuzzy multiplication  $a_{ik}^T \cdot c_{kj}^T \leq b_{ik}^T \cdot c_{kj}^T$ ,  $a_{ik}^I \cdot c_{kj}^I \leq b_{ik}^I \cdot c_{kj}^I$  and  $a_{ik}^F \cdot c_{kj}^F \geq b_{ik}^F \cdot c_{kj}^F$  for  $j = \overline{1, p}$ .

$$\text{By fuzzy addition } \sum_{k=1}^n a_{ik}^T \cdot c_{kj}^T \leq \sum_{k=1}^n b_{ik}^T \cdot c_{kj}^T,$$

$$\sum_{k=1}^n a_{ik}^I \cdot c_{kj}^I \leq \sum_{k=1}^n b_{ik}^I \cdot c_{kj}^I \text{ and } \sum_{k=1}^n a_{ik}^F \cdot c_{kj}^F \geq \sum_{k=1}^n b_{ik}^F \cdot c_{kj}^F.$$

Hence,  $AC \leq BC$ .

Similarly, we can see  $DA \leq DB$ .

**Theorem 4.4** The set  $\mathbf{F}_{m \times n}$  is a commutative semiring with identity  $\mathbf{0}$  and  $\mathbf{J}$ .

**Proof** We have  $A + \mathbf{0} = A$  and  $A \bullet \mathbf{J} = A$  for all  $A \in \mathbf{F}_{m \times n}$ . So, we say that zero neutrosophic matrix  $\mathbf{0}$  is the additive identity and universal neutrosophic matrix  $\mathbf{J}$  is the multiplicative identity.

$$A + \mathbf{J} = \mathbf{J} \text{ and } A \bullet \mathbf{0} = \mathbf{0}.$$

$$\text{Let } A, B, C \in \mathbf{F}_{m \times n} \text{ such that } A = [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle],$$

$$B = [\langle b_{ij}^T, b_{ij}^I, b_{ij}^F \rangle], C = [\langle c_{ij}^T, c_{ij}^I, c_{ij}^F \rangle].$$

$$\begin{aligned} A + (B + C) &= [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle] + [\langle \max\{b_{ij}^T, c_{ij}^T\}, \max\{b_{ij}^I, c_{ij}^I\}, \min\{b_{ij}^F, c_{ij}^F\} \rangle] \\ &= [\langle \max\{a_{ij}^T, b_{ij}^T, c_{ij}^T\}, \max\{a_{ij}^I, b_{ij}^I, c_{ij}^I\}, \min\{a_{ij}^F, b_{ij}^F, c_{ij}^F\} \rangle]. \end{aligned}$$

and

$$\begin{aligned} (A + B) + C &= [\langle \max\{a_{ij}^T, b_{ij}^T\}, \max\{a_{ij}^I, b_{ij}^I\}, \min\{a_{ij}^F, b_{ij}^F\} \rangle] + [\langle c_{ij}^T, c_{ij}^I, c_{ij}^F \rangle] \\ &= [\langle \max\{a_{ij}^T, b_{ij}^T, c_{ij}^T\}, \max\{a_{ij}^I, b_{ij}^I, c_{ij}^I\}, \min\{a_{ij}^F, b_{ij}^F, c_{ij}^F\} \rangle]. \end{aligned}$$

Hence,  $A + (B + C) = (A + B) + C$ . Similarly, we can show that

$$A \bullet (B \bullet C) = (A \bullet B) \bullet C.$$

So, we obtain associativity law under  $+$  and  $\bullet$ .

Now, we show that  $A + (A \bullet B) = A \bullet (A + B)$ .

$$\begin{aligned} A + (A \bullet B) &= [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle] + [\langle \min\{a_{ij}^T, b_{ij}^T\}, \min\{a_{ij}^I, b_{ij}^I\}, \max\{a_{ij}^F, b_{ij}^F\} \rangle] \\ &= [\langle \max\{a_{ij}^T, \min\{a_{ij}^T, b_{ij}^T\}\}, \max\{a_{ij}^I, \min\{a_{ij}^I, b_{ij}^I\}\}, \min\{a_{ij}^F, \max\{a_{ij}^F, b_{ij}^F\}\} \rangle] \\ &= [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle] \\ &= A. \end{aligned}$$

Similarly, we see  $A \bullet (A + B) = A$ . Hence, absorption is satisfied.

Now, we prove  $A \bullet (B + C) = (A \bullet B) + (A \bullet C)$ .

Suppose that  $A \leq B, C$ .

$$\begin{aligned} A \bullet (B + C) &= [\langle \min\{a_{ij}^T, \max\{b_{ij}^T, c_{ij}^T\}\}, \min\{a_{ij}^I, \max\{b_{ij}^I, c_{ij}^I\}\}, \max\{a_{ij}^F, \min\{b_{ij}^F, c_{ij}^F\}\} \rangle] \\ &= [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle] \\ &= A. \end{aligned}$$

$$(A \bullet B) + (A \bullet C) = [\langle \min\{a_{ij}^T, b_{ij}^T\}, \min\{a_{ij}^I, b_{ij}^I\}, \max\{a_{ij}^F, b_{ij}^F\} \rangle]$$

$$\begin{aligned} &+ [\langle \min\{a_{ij}^T, c_{ij}^T\}, \min\{a_{ij}^I, c_{ij}^I\}, \max\{a_{ij}^F, c_{ij}^F\} \rangle] \\ &= [\langle \max\{\min\{a_{ij}^T, b_{ij}^T\}, \min\{a_{ij}^T, c_{ij}^T\}\}, \max\{\min\{a_{ij}^I, b_{ij}^I\}, \min\{a_{ij}^I, c_{ij}^I\}\}, \end{aligned}$$

$$\begin{aligned} &\min\{\max\{a_{ij}^F, b_{ij}^F\}, \max\{a_{ij}^F, c_{ij}^F\}\} \rangle] \\ &= [\langle a_{ij}^T, a_{ij}^I, a_{ij}^F \rangle] \\ &= A \end{aligned}$$

So, we obtained the desired equality.

If  $A \geq B, C$ , then we have two cases.

If  $A \geq B \geq C$ , then we obtain  $A \bullet (B + C) = (A \bullet B) + (A \bullet C)$  from the above equalities, and if  $A \geq C \geq B$ , similarly we see  $A \bullet (B + C) = (A \bullet B) + (A \bullet C)$ . Hence, distributivity law is hold.

**Theorem 4.5** The set  $F_{m \times n}$  is a vector space under the operations neutrosophic matrix addition and scalar multiplication.

**Proof** Let  $A, B, C \in \mathbf{F}_{m \times n}$ . We have  $A+B = B+A$  and  $A+(B+C) = (A+B)+C$ . Commutative law and associative low hold in  $\mathbf{F}_{m \times n}$ .

For all  $A \in \mathbf{F}_{m \times n}$ , there exist an element  $\mathbf{0} \in \mathbf{F}_{m \times n}$  such that

$$A + \mathbf{0} = A.$$



For  $k \in F$ , by Definition 3.6 and Theorem 4.4, we obtain

$$\begin{aligned} k(A + B) &= k\mathbf{J} \bullet (A + B) \\ &= k\mathbf{J} \bullet A + k\mathbf{J} \bullet B. \\ &= kA + kB \end{aligned}$$

Again, for  $k_1, k_2 \in F$ ,

$$\begin{aligned} (k_1 + k_2)A &= (k_1 + k_2)\mathbf{J} \bullet A \\ &= (k_1\mathbf{J} + k_2\mathbf{J}) \bullet A. \\ &= k_1\mathbf{J} \bullet A + k_2\mathbf{J} \bullet A \\ &= k_1A + k_2A \end{aligned}$$

Hence,  $F_{m \times n}$  is a vector space over  $F$ .

## 5. CONCLUSION

It is well-known that matrices play an important role in computer science and technology. However, the classical matrix theory sometimes fails to solve the problems involving uncertainties, occurring in an imprecise environment Thomas [18] introduce fuzzy matrices to represent fuzzy relation in a system based on fuzzy set theory. According to this idea, we introduce the notion of a neutrosophic matrix to handle the computer science problems involving neutrosophic inputs which is an extension of the intuitionistic fuzzy matrix [17].
